




Shipping Soon: Version 4.0 of Orchard Harvest™ LIS

In the last issue of this newsletter we announced that a new version of Harvest LIS (formerly Costello™) would be available this summer. We are pleased to report that the software is passing the final

stages of testing with flying colors. This means that we will begin shipping this version in a few short weeks. Customers on support contracts should receive their upgrade information in early to mid-August.

As you may recall, we have previously referred to this release as version 3.5. When we began creating this new version, we did not know how many changes we would be able to include. But thanks to the hard work of our development team, we were able to bring you more new features and enhancements than we originally planned. Based on the extent of the changes, we decided that this new version was, in fact, a major release. As such, we increased its version number one whole number to version 4.0.

Some of the new and enhanced features are listed in the diagram on the left. Look for additional details on page 3 about Harvest Webstation, one of the exciting new optional modules for your Harvest LIS. ❖

What is a Log File and Why is it Important?

Using a log file with Harvest LIS is extremely important, but do you know why? This article describes the purpose of a log file and answers some common questions our customers have about using log files.

What is a log file and why is it important?

A feature of the 4D Backup program is the ability to track all changes made in the data file between backups. The file that stores these transaction records is the 4D

log file. This file is used to assist in the recovery of a data file from a backup.

If a data file has become damaged and it is necessary to recover from a backup, the presence of an active log file allows the data file to be restored to the point of the crash. Without a log file being present, the data file can only be recovered to the point of the last backup.

How do I verify that a log file is in use?

To check on the status of the log file on your system, examine the Harvest LIS Server Process window. If a log file is in use, the name of the log file will be listed below the data file name in the Process window. If there is no log file named in this location, then no log file is in use.

If there is no log file, how can I create one?

To create a log file, you must perform a 4D backup of the data file. To do so, follow these steps:

1. Quit Harvest LIS on all workstations. It is imperative that no users attempt to run Harvest LIS during this procedure.

2. Perform a backup of the data file. You can do this by clicking on the Backup menu in 4D server, selecting Full Backup, then clicking on Backup.
3. When the Full Backup is complete, click on File/Select Log File in 4D server.
4. Select the New button in the window.
5. Use the default name and location for the log file and click Save.
6. The 4D Server Process window should now update with the name of the log file.
7. Harvest LIS can now be started on the workstations.

How does a log file become disassociated from a data file?

This usually occurs when 4D server is not shut down properly. You should always quit 4D Server by selecting File/Exit from the menu, by pressing [CTRL] + [Q], or by clicking the 'X' in the upper right corner of the window. Any other method will break the connection between the log file and the data file.

Correctly Exiting Harvest LIS

We have recently received several technical support calls with problems caused by exiting Harvest LIS incorrectly.

From these calls it seems that a number of staff at various sites may be using the End Task function of Windows NT Task Manager to routinely close Harvest LIS or Costello. This is not the proper way to exit the program, and using this method may result in data file damage if this done on the server or a single-user workstation.

Under normal circumstances you should exit the program in one of three ways:

1. Select File/Exit, then click OK at the prompt.
2. Press [CTRL] + [Q], then click OK at the prompt.
3. Click on the 'X' in the upper right corner of the window, then click OK at the prompt.

End Task should be used only as a last resort if the LIS is 'locked up' (you have waited several minutes and no activity has taken place) and cannot be closed any other way. Contact Technical Support at 800-571-5835 if this situation occurs frequently. ❖

Results may also be delivered to users' Harvest Webstation accounts. This means that patient records are readily available for viewing, faxing, and printing. This eliminates the frustrating and time-consuming task of tracking down misplaced reports. To ensure that patient information remains confidential, security settings may be defined to only allow access to a user's own patient results.

Feedback Forum: Requests for Modification

As in past issues of *news@orchard*, we invite your input on feature requests and potential enhancements to Harvest LIS.

This month's issues center on reimbursement for lab procedures. Please consider each of the questions below for both your Medicare payor and for your other payors.

1. Procedure Code Modifiers (for billing): How are these used by your practice? Do you use modifiers for anything besides a signed Advance Beneficiary Notice? Are the modifiers that you use assigned at the national, regional, or local level?

2. Supervising Physicians: Do you have non-physician providers who order lab procedures, and are those procedures reimbursed at a differ-

ent reimbursement rate? If so, how are these providers identified and tracked in your billing system?

As always, you may submit your own suggestions as well as comment on the items listed here.

3. Frequency of Testing: What are the rules applied to frequency of testing restrictions for your practice? Are you allowed to conduct and be paid for screening procedures as long as you work within frequency restrictions? Are your frequency restrictions always defined as a number of days? For example, if you only do one procedure of a certain type per year, is the frequency measured as 365 days since the last procedure or as anytime during a calendar year?

4. Inpatient vs. Outpatient Status: Is it important to you to track this status in Harvest? If so, is it for bill-

ing reasons, and exactly how would you use this status information? Does your current billing system now track this status and apply it to all lab and non-lab procedures for that patient under that encounter number or on that date of service?

5. Maximizing Reimbursement: In addition to the topics above, how could we augment Harvest LIS to help you make sure you are receiving all of the reimbursement that you are entitled to?

Your feedback is vital to keep the feature set of Harvest LIS current with your needs.
