Feature Focus: Orchard Harvest LIS Microbiology Module

orchard Harvest LIS 4.0 features an optional Microbiology Module that allows you to create a nearly paperless environment for performing microbiology procedures.

Electronic Worksheet

The core of the Microbiology Module is its electronic worksheet that allows you to document observations, add new tests, as well as read and evaluate results performed manually or by automated methods. The Microbiology Module supports up to four isolates and their corresponding susceptibilities.

Instrument Interfaces

Harvest LIS 4.0 supports interfaces with the Biomerieaux Vitek and Dade Microscan series instruments, two of the most popular microbiology instruments.

Label Printing

Use the updated Label Setup Wizard to design labels that you can print for microbiology primary and subculture media. When you scan barcode information on microbiology labels with the optional barcode scanner, Harvest LIS automatically finds and opens the scanned culture in the microbiology electronic worksheet.


Result Delivery

You can send microbiology results using paper, fax, or email reports, or through an interface to an HIS or EMR system. Orchard HarvestTM Webstation users can also view results via the web.

ech Performing Software Verification

A ny time you change your system (modify instrument interfaces, upgrade or update the software or hardware, or make any other changes), we recommend that you perform a verification of Harvest LIS.

Performing a software verification procedure will help you confirm that your LIS is functioning as expected. As a part of this process, you should confirm that results, billing, and interface information is correctly sent to and received from systems outside of Harvest LIS.

Your facility is responsible for performing this verification. However, you may obtain a copy of the Orchard Harvest LIS Software Verification Guidelines to help with this activity.

Note that the Orchard Harvest LIS Software Verification Guidelines may or may not cover the requirements set forth by your facility's regulating agency. We recommend that you consult that agency to confirm the steps required to verify your LIS.

Requests for Modification: Epidemiology Reporting

W e have received several requests to add an epidemiology report to Harvest LIS. We are looking for any input you may have on epidemiology reporting.

Please consider each question below as you provide feedback on the proposed report.

To whom do you report? The CDC? A local agency? If a local agency, does the local agency eventually forward your reports to the CDC?

What are the minimum required data elements?

Do the required data elements include patient demographics, and if so, do they include unusual demographics like municipal code and/or county? Do you create epidemiology reports electronically, on paper, or both?

Can you provide a format or template for the report (e.g., Microsoft Excel or HL7)?

Do the epidemiology reports need to contain race and/or ethnicity information?

Should the reports intentionally exclude all specific patient identification?

What procedures or tests must be re-

ported? Are there optional procedures to report?

Are the results for all procedures required, or only those with a certain result? For example, would the report contain all occurrences of GC/Chlam or only positive occurrences?

Could existing utilities within
Harvest LIS (e.g., Result Browser, or
Custom Reports) produce the desired
epidemiology reports? If modifications
to existing reporting features in Harvest
LIS would create a satisfactory

epidemiology report, what would those modifications be?
