Prolonging the Life of Your Tape Drives

art of your initial hardware shipment when you purchase an Orchard LIS is a tape drive for performing a secondary backup of your data file. This backup provides a means to restore your data file in the event of a serious or catastrophic server event. Since this backup is on a removable media, this also facilitates the storage of the data file at a secure off-site location.

Over a period of time, the read/write head and tape sensor hole will become dirty from the build up of metal oxide that is lost from the backup tapes during normal usage. Addi-

tionally, most servers are placed in the laboratory, which is not a "Clean Room" environment, so they are exposed to high levels of dust. Eventually, the buildup of this material will affect the operation of the tape hardware. Common errors can be the failure of the tape program to verify the backup, failure of the software to detect a tape when inserted into the drive, and tape media errors.

We have installed HP T4i 20GB compressed storage capacity tape

drives in most or our HP E800 servers for the last couple of years. While other models of Hewlett Packard tape drives require specific cleaning tapes or procedures using alcohol swabs, the HP T4i tape drive does not have such cleaning procedures defined or sanctioned by HP.

The HP recommended cleaning process for all HP T4i tape drives is to perform five consecutive retensioning

> operations to tighten the tape. HP recommends that this retensioning procedure be done weekly due to the dusty environments to which most lab servers are subjected.

The warranty period for these T4i drives is two years. Within this period, HP will replace a defective drive with a new or refurbished unit. Outside the two-year period, the burden of repair or replacement falls on the user.

By following the approved retensioning cleaning procedure, you can prolong the life of the tape unit and the security of your data file. Since it is normal for tape media to lose its metal oxide coating and to stretch, we suggest that you date the backup

tapes when placed into use and that you replace them yearly.

Since there are several different types of tape backup software being used, the retensioning procedure varies. Contact Orchard Software Technical Support at (800) 571-5835 for more information or guidance on how to perform a retension. .
